R E S O L U T I O N

RESOLUTION E-3129. SOUTHERN CALIFORNIA EDISON COMPANY (EDISON) AUTHORIZED TO MODIFY THE APPLICABILITY STATEMENT OF ITS EXPERIMENTAL REAL TIME PRICING SCHEDULE NO. RTP-2.

BY ADVICE LETTER 815-E, FILED ON DECEMBER 29, 1988.

SUMMARY

1. Edison requests authorization to modify the Applicability Statement of its Experimental Real Time Pricing Schedule No. RTP-2, to state that it will be closed to new customers as of January 1, 1990 and will expire on December 31, 1991.
2. This Resolution approves Edison's request.

BACKGROUND

1. The presently authorized Experimental Schedule No. RTP-2 is applicable to Edison's commercial and industrial customers eligible for service under Schedule No. TOU-8. Schedule RTP-2 is closed to new customers as of January 1, 1990 and expires December 31, 1990. This modification provides an additional year for Edison to implement and complete the experiment as represented in Edison's 1988 General Rate Case (Decision 87-12-066).
2. Edison requests the additional year because of problems with software design, customer selection, and installation of equipment necessary for the test.

DISCUSSION

1. The Commission Evaluation and Compliance Division (CACD) has reviewed this filing and believes it is reasonable to extend the duration of Schedule RTP-2 in order to gain more experience with real time pricing rate schedules.

2. This filing will not increase any existing rate or charge, conflict with other schedules or rules, nor cause withdrawal of service.
3. Edison has requested, in compliance with Section IV.B of General Order 96-A, to make this filing effective 40 days after the date filed.
4. Public notification has been made by supplying copies of this filing to other utilities and parties requesting notification of advice filings.

PROTESTS

1. No protests have been received by CACD.

FINDINGS

1. We find Edison's request by Advice Letter 815-E to modify the Applicability Statement of its Experimental Schedule RTP-2, as discussed above, to be just and reasonable.
2. This filing will not increase or decrease any rate or charge, cause the withdrawal of service, nor conflict with other schedules or rules.

THEREFORE, IT IS ORDERED that:

1. Southern California Edison Company, as requested by Advice Letter 815-E, is authorized to modify the Applicability Statement of its Experimental Schedule No. RTP-2, to state that it will be closed to new customers as of January 1, 1990 and will expire on December 31, 1991.
2. Advice Letter 815-E, and accompanying tariff sheets shall be marked to show that they were approved by Commission Resolution E-3129 .
3. This Resolution is effective today.
