RESOLUTION E-3294. SAN DIEGO GAS AND ELECTRIC COMPANY REQUEST APPROVAL OF TERRITORY SERVED MAP 1-B.

BY ADVICE LETTER 837-E, JANUARY 3, 1992.

SUMMARY

1. San Diego Gas and Electric Company (SDG&E) requests to file Territory Served Map 1-B which reflects the realignment of service territory boundaries shared by SDG&E and Southern California Edison (SCE).

2. This resolution approves the request.

BACKGROUND

1. By Decision (D.) 91-12-005, dated December 4, 1991, the Commission adopted the joint proposal of SCE and SDG&E to realign the service territory boundaries between the two Companies at the Coto de Caza development in Southern Orange County.

2. SDG&E filed Advice Letter (AL) 837-E to comply with D.91-12-005.

3. The Commission Advisory and Compliance Division noticed that a map in D. 91-12-005 did not match the map filed in A. L. 837-E.

4. SDG&E petitioned the Commission to modify D.91-12-005 because an incorrect map had been included in D.91-12-005. SDG&E represents that the map filed in A. L. 837-E is the correct map.

5. The Commission accepted SDG&E's petition for modification of D.91-12-005 by issuing D.92-09-071, agreeing that maps specified in D.91-12-005 should be revised.

DISCUSSION

1. Although the map filed by SDG&E is similar to one of the maps in D.91-12-005, there are important boundary differences between the two maps.

2. Maps filed as parts of the tariffs submitted to the Commission for approval should match the map(s) authorized by the relevant Commission Decision.

1. Public notice of this filing has been made by publication in the Commission's calendar on January 7, 1992, and by mailing copies of the filing to adjacent utilities and government entities.

PROTESTS

1. No protests to this Advice Letter were received by the Commission Advisory and Compliance Division.

FINDINGS

1. A. L. 837-E complies with Commission D.92-09-071. The map submitted by SDG&E matches a map authorized by D.92-09-071.

2. Because A. L. 837-E contains the correct version of Territory Served Map 1-B, AL 837-E will be effective on the date specified by D.91-12-005, viz January 5, 1992. Resolution E-3294 SDG&E/AL837-E/GWB/

THEREFORE,

IT IS ORDERED that:

1. Advice Letter 837-E as submitted by San Diego Gas and Electric Company shall be marked to show that it was approved for filing and for implementation by Commission Resolution E-3294.

2. This Resolution is effective today.
