RESOLUTION

RESOLUTION E-3351. SOUTHERN CALIFORNIA EDISON REQUEST FOR EXTENSION OF EXPIRATION DATE FOR RATE SCHEDULES TOU-ALMP-2 and TOU-PA-1 FROM JUNE 3, 1995 TO SEPTEMBER 30, 1995.

BY ADVICE LETTER 1018-E, FILED ON OCTOBER 14, 1993.

SUMMARY

1. Rate schedules TOU-ALMP-2 and TOU-PA-1 are two time-of-use rate schedules available to agricultural and pumping customers of Southern California Edison (Edison). In Edison's last General Rate Case (Decision (D.)92-06-020), the Commission directed Edison to eliminate both of these rate schedules on June 4, 1995, the expected date when the new rates adopted in Edison's next General Rate Case would take effect.

2. Edison requests permission to extend the expiration date of these rate schedules to September 30, 1995. This is the revised date after which Edison's new General Rate Case rates will take effect.

3. This Resolution approves Edison's request.

BACKGROUND

1. Rate schedules TOU-ALMP-2 and TOU-PA-1 are two time-of-use rate schedules available to agricultural and pumping customers of Southern California Edison (Edison). Approximately 1,200 customers currently take service on these schedules.

2. In Edison's last General Rate Case (Decision (D.)92-06-020), the Commission directed Edison to eliminate both of these rate schedules on June 4, 1995, the expected date when the new rates adopted in Edison's next General Rate Case would take effect. Subsequent to D.92-06-020, the Commission revised its schedule for processing Edison's General Rate Case application in D.93-07-030. Under this revised processing plan, Edison's new General Rate Case rates will now take effect on October 1, 1995.

NOTICE

Public notice of Advice Letter 2181 was made by publication in the Commission calendar and by Edison mailing copies to all interested parties.

PROTESTS

1. No protests were received for this Advice Letter filing.

DISCUSSION

1. The original expiration date for these two rate schedules was based on the Commission's adopting new General Rate Case rates on June 3, 1995. Since the Commission has subsequently changed the implementation date of Edison's next General Rate Case to October 1, 1995, it is reasonable to extend the expiration date of these two rate schedules. Otherwise, all customers served on this rate schedule would have to change their rate schedules twice in a four-month period, first with the end of the existing rate schedules on June 3, 1995 and second when Edison's new rate schedules go into effect on October 1, 1995.

FINDINGS

1. Edison's request to extend the expiration date of its TOU-ALMP-2 and TOU-PA-1 rate schedules from June 3, 1995 to September 30, 1995 is reasonable.

THEREFORE, IT IS ORDERED that:

1. The expiration date of Southern California Edison's TOU-ALMP-2 and TOU-PA-1 rate schedules shall be changed from June 3, 1995 to September 30, 1995.

2. This Resolution is effective today.
