Order Authorizing Revisions in Tariff Schedules and Deviation from SUBJECT: the Tariff Schedules Effective prior to the date of the Revision.

IT IS ORDERED that authority be granted to the SOUTHERN CALIFORNIA GAS COMPANY, under Section 491 of the Public Utilities Code, to make the above-numbered sheets 8338-G through 8354-G, effective on July 31, 1961, and that authority be granted the afore-mentioned Company, under Section 532 of the Public Utilities Code, to deviate from its filed tariff schedules G-6, G-45, G-50 and G-53, as effective during July 1961, in order to refund the facility charge applicable to the Community of Cherry Valley for the month of July 1961.
