R E S O L U T I O N

SUBJECT: Order Authorizing Changes in Tariff Schedules on Less Than Statutory Notice.

WHEREAS: SOUTHERN CALIFORNIA GAS COMPANY, by Advice No. 553, filed June 22, 1962, having requested authority under Section 491 of the Public Utilities Code to make effective on less than 30 days' notice, namely on July 1, 1962, certain revisions in its tariff schedules as designated in new Schedule No. G-54S, Contract Forms and Table of Contents, as set forth on Cal. P.U.C. Sheets Nos. 8492-G to 8501-G, inclusive; and

WHEREAS: SOUTHERN COUNTIES GAS COMPANY OF CALIFORNIA, by Advice No. 429, filed June 22, 1962, having requested authority under Section 491 of the Public Utilities Code to make effective on less than 30 days' notice, namely on July 1, 1962, certain revisions in its tariff schedules as designated in new Schedule No. G-54S, Contract Forms and Table of Contents as set forth on Cal. P.U.C. Sheets Nos. 3473-G to 3480-G, inclusive; and good cause appearing,

IT IS ORDERED that authority be granted under Section 491 of the Public Utilities Code to make the sheets effective on July 1, 1962.

IT IS FURTHER ORDERED that Southern California Gas Company and Southern Counties Gas Company of California are hereby placed on notice that should the operation of this contract cast a burden upon their other operations they shall assume such burden and such burden shall not be passed on to their other rate payers.

IT IS FURTHER ORDERED that the above sheets shall be marked to show that such sheets were issued under Resolution of the Public Utilities Commission of the State of California No. G-1175.
