RESOLUTION

SUBJECT: Order Authorizing Reductions in Tariff Schedules on Less Than Statutory Notice.

WHEREAS: SOUTHWEST GAS CORPORATION, by Advice Letter No. 53 filed January 24, 1963, having requested authority under Sections 455, 490 and 491 of the Public Utilities Code to reduce rates in each of its gas service tariff schedules, as designated in Table of Contents and as set forth in Revised Cal. P.U.C. Sheets Nos. 292-G to 298-G, inclusive, to be effective on less than 30 days' notice, namely, January 31, 1963,

WHEREAS: SOUTHWEST GAS CORPORATION further requests that the rates to be made effective on January 31, 1963 be applicable to meter readings on and after said date, which condition is different from that required by Section IV. B. of General Order No. 96-A unless otherwise ordered or authorized; therefore, good cause appearing

IT IS ORDERED that authority be granted under Sections 490 and 491 of the P. U. Code to make said sheets effective on January 31, 1963 and to make said effective date of such schedules applicable for meter readings taken on and after said date.

IT IS HEREBY FURTHER ORDERED that SOUTHWEST GAS CORPORATION shall furnish a written report to the Commission within forty days after the date of this resolution, setting forth its comments on the desirability of incorporating the following or a comparable statement in the contingent offset clause of its rate schedules:

> "In addition to the amounts specified herein, the base and effective rates shall be reduced to fully reflect any reduction made by Pacific Gas and Electric Company as a result of reductions by its out-of-state suppliers. Any refunds received from Pacific Gas and Electric Company as a result of refunds from out-of-state suppliers shall flow through to the customers."

IT IS FURTHER ORDERED that the changes in contingent offset charges incorporated in this filing shall not be construed to be a final determination of the amounts of such charges which the Commission may fix in the future. IT IS FURTHER ORDERED that the above sheets shall be marked to show that such sheets were issued under Resolution of the Public Utilities Commission of the State of California No. G-1192.
