SUBJECT: Order Authorizing Reductions in Tariff Schedules on Less Than Statutory Notice.

WHEREAS: SOUTHERN CALIFORNIA EDISON COMPANY, by Advice No. 4-G, filed June 5, 1964 having requested authority under Sections 455, 490 and 491 of the Public Utilities Code to (1) reduce rates for a decrease in licuefied petroleum gas, (2) withdraw General Service Schedule Nos. G-80 and G-81 and (3) modify Rule No. 2 by deleting gas furnished with a heat content of 550 Btu per cubic foot as designated in Table of Contents and as set forth in Cal. P.U.C. Sheets Nos. 54-G to 58-G, inclusive, to be effective on less than 30 days' notice, namely, retroactive from the date of filing and authorization to May 17, 1964, and

WHEREAS: SOUTHERN CALIFORNIA EDISON COMPANY further requests that the rates be applicable to meter readings on and after said date which is different from that required by Section IV.B. of General Order No. 96-A unless otherwise ordered or authorized, and

WHEREAS: SOUTHERN CALIFORNIA EDISON COMPANY on April 25, 1964 completed its gas service standard heating value conversion from 550 Btu gas to 1100 Btu gas, and

WHEREAS: SOUTHERN CALIFORNIA EDISON COMPANY substantiates by affidavit a decrease in the cost of liquefied petroleum as of April 17, 1964, therefore good cause appearing,

IT IS ORDERED that authority be granted under Sections 455, 490, and 491 of the Public Utilities Code to make said sheets effective for meter readings on and after May 17, 1964.

IT IS FURTHER ORDERED that the above sheets shall be marked to show that such sheets were issued under Resolution of the Public Utilities Commission of the State of California No. G-1235.
