SUBJECT: Order Authorizing Deviations From Filed Tariffs
for a Gas Main Extension

WHEREAS: PACIFIC GAS AND ELECTRIC COMPANY by Advice Letter No. 516-G, filed May 21, 1965 having requested authority under its Rule No. 15.E.7 and Section 532 of the Public Utilities Code to deviate from its filed Gas Tariff Schedules with respect to waiving gas main extension advances for customers in the extension of natural gas service in San Geronimo Valley, Marin County, and set forth on Cal. P.U.C. Sheets Nos. 7623-G to 7626-G, inclusive, and

WHEREAS: This extension is to furnish gas for general service along some 23 miles of distribution mains, thereby making it impractical to allocate or separate the respective extension installation costs by customers, and

WHEREAS: Special conditions applicable to this extension will be agreed upon by each customer prior to commencing construction, and

WHEREAS: Such deviation from the filed gas tariffs will facilitate procurement of the necessary applications for natural gas service, therefore, good cause appearing,

IT IS ORDERED that authority be granted under Section 532 of the Public Utilities Code to make said tariff sheets effective on June 30, 1965.

IT IS FURTHER ORDERED that the above sheets be marked to show that such sheets were issued under Resolution of the Public Utilities Commission of the State of California No. G-1281.
