Order Authorizing Revisions in Tariff Schedules on Less SUBJECT: Than Statutory Notice Which Will Result in Technical Rate Increases and Modification of Commission Orders.

PACIFIC GAS AND ELECTRIC COMPANY by Advice No. 536-G, filed WHEREAS: January 12, 1966, having requested authority under Sections 454, 455, 490 and 491 of the Public Utilities Code to reduce rates, to change certain zoned territory as designated in Table of Contents and as set forth in revised Cal. P.U.C. Sheets Nos. 7799-G to 7826-G, inclusive, to be effective on less than 30 days' notice, namely, for service on and after February 2, 1966, and,

WHEREAS: These proposed rate area revisions will result in a \$24,300 decrease in charges for gas service to 2469 customers as of February 2, 1966, and,

WHEREAS: The revisions of the San Francisco and Shasta Rate Area Maps are minor modifications pf prior order of this Commission, and

WHEREAS: The rates resulting from the revisions of the Peninsula-San Jose, Red Bluff, San Francisco, and Shasta Rate Area Maps will only result in technical increases, and we find that increases resulting from the above tariff schedule changes are justified; therefore, good cause appearing,

IT IS ORDERED that authority be granted under Section 491 of the Public Utilities Code to make said sheets effective for service on or after February 2, 1966.

IT IS FURTHER ORDERED that authority be granted under Code Section Nos. 490 and 454 to transfer a portion of Shasta Rate Area to Red Bluff Rate Area and to change a portion of the boundary of the San Francisco Rate Area with the North Peninsula Rate Area.

IT IS FURTHER ORDERED that the above tariff sheets be marked to show that such sheets were issued under Resolution of the Public Utilities Commission of the State of California No. G-1311.
