SUBJECT: Order Authorizing Changes in Territorial Boundary Lines
Which Will Result in Technical Increases

WHEREAS: SOUTHERN CALIFORNIA GAS COMPANY by Advice Letter No. 674 filed September 6, 1966, having requested authority under Sections 454, 455 and 491 of the Public Utilities Code to make revisions in its common territorial boundary line with Southern Counties Gas Company of California, as established by Decision No. 56878, dated June 24, 1958, in joint Application No. 39636, by an interchange of territory with Southern Counties Gas Company of California and to make such changes effective on less than statutory notice, as set forth on Cal. P.U.C. Sheets Nos. 9750-G to 9765-G, inclusive, and

WHEREAS: Such revisions of certain portions of the common boundary between the service areas of Southern California Gas Company and Southern Counties Gas Company of California appear to be in accordance with the intent and provisions of Decision No. 56878, dated June 24, 1958, in joint Application No. 39636, and

WHEREAS: Under certain conditions the portions of areas acquired will result in potentially increased charges at the rates now in effect, thus resulting in technical increases, and

WHEREAS: The temporary establishment of applicable supplemental rate schedules will provide for a 25¢ per month credit for customers commencing service in Southern California Gas Company areas affected by these boundary changes prior to October 1, 1969, and substantially eliminate the technical increases to firm customers, and

WHEREAS: These boundary adjustments coincide with such changes concurrently granted by Resolution No. G-1344 for Southern Counties Gas Company, and

WHEREAS: We find that such technical increases resulting from the transfer of the service areas are justified; therefore, good cause appearing,

IT IS ORDERED that authority be granted under Sections 454 and 491 of the Public Utilities Code to make the above sheets effective on less than regular statutory notice, namely, on September 20, 1966.

IT IS FURTHER ORDERED that the above sheets be marked to show that such sheets were issued under Resolution of the Public Utilities Commission of the State of California No. G-1343.
