> SUBJECT: Order Authorizing Changes in Territorial Boundary Lines Which Will Result in Technical Increases and Transfer of Utility Property

WHEREAS: SOUTHERN COUNTIES GAS COMPANY OF CALIFORNIA by Advice Letter No. 524, filed September 6, 1966, having requested authority under Sections 454, 455, 491 and 851 of the Public Utilities Code to make revisions in its common territorial boundary line with Southern California Gas Company, as established by Decision No. 56878, dated June 24, 1958, in joint Application No. 39636, by an interchange of territory with Southern California Gas Company, and to transfer certain utility property to Southern California Gas Company, and to make such changes effective on less than statutory notice, as set forth on Cal. P.U.C. Sheets Nos. 4354-G to 4365-G, inclusive, and

WHEREAS: Such revisions of certain portions of the common boundary between the service areas of Southern Counties Gas Company and Southern California Gas Company appear to be in accordance with the intent and provisions of Decision No. 56878, dated June 24, 1958, in joint Application No. 39636, and

WHEREAS: Under certain conditions the portions of areas transferred will result in potentially increased charges at the rates now in effect, thus resulting in technical increases, and

WHEREAS: The temporary establishment by Southern California Gas Company of applicable supplemental rate schedules will provide for a  $25\phi$  per month credit for customers commencing service in Southern California Gas Company areas affected by these boundary changes prior to October 1, 1969, and substantially eliminate the technical increases to firm customers, and

WHEREAS: The utility property to be transferred represents equipment necessary to supply two small farm-tap customers, and

WHEREAS: These boundary adjustments coincide with such changes concurrently granted by Resolution No. G-1343 for Southern California Gas Company, and

WHEREAS: We find that such technical increases resulting from the transfer of the service areas are justified; therefore, good cause appearing,
