**SUBJECT:** Order Authorizing Changes in Tariff Schedules Which Will Result in Rate Increases on Less Than Statutory Notice

**WHEREAS:** SOUTHERN CALIFORNIA GAS COMPANY, by Advice No. 780, filed November 28, 1969, having requested authority under Sections 454, 491 and 532 of the Public Utilities Code to make revisions in its tariff schedules as designated in Schedule No. G-60, Resale Natural Gas Service, and to file a Seventh Supplemental to a Gas Service Agreement with the City of Long Beach as set forth on Cal. P.U.C. Sheets Nos. 10704-G through 10710-G, inclusive, effective on less than 30 days' notice, namely, December 1, 1969, and

**WHEREAS:** The City of Long Beach requested these changes as made and entered into in the Seventh Supplemental Service Agreement and duly adopted on November 25, 1969, pursuant to Resolution No. C-20609, Resolutions of the City Council of the City of Long Beach, and

**WHEREAS:** These changes include an increase in the Daily Contract Demand Rate from \$2.53 per Mcf to \$2.976 per Mcf and a decrease in the Commodity Rate from 33.287¢ per Mcf to 31.819¢ per Mcf, and

**WHEREAS:** Similar changes for further extension and modification of the Long Beach service agreement dated March 22, 1961, were authorized by Resolution No. G-1287, dated June 29, 1965; Resolution No. G-1314, dated March 29, 1966; Resolution No. G-1405, dated December 27, 1967; and Resolution No. G-1425, dated December 3, 1968, and

**WHEREAS:** We find that such increases resulting from the above changes in the tariff schedules are justified; therefore, good cause appearing,

IT IS ORDERED that authority be granted under Sections 454, 491 and 532 of the Public Utilities Code to make said sheets effective on December 1, 1969.

IT IS FURTHER ORDERED that the above tariff sheets shall be marked to show that such sheets were issued under Resolution of the Public Utilities Commission of the State of California No. G-1457
