SUBJECT: Order Authorizing Contract Filed Under Section X, Paragraph A of General Order No. 96-A, to be Effective on Less Than Statutory Notice.

WHEREAS: PACIFIC LIGHTING SERVICE COMPANY, by Advice Letter No. 56, filed on June 12, 1970, having requested authority under Section X, Paragraph A, of General Order No. 96-A and Section 491 of the Public Utilities Code to authorize Pacific Lighting Service Company to participate in an agreement dated October 15, 1969, between Pacific Lighting Service Company, Southern California Gas Company, Southern Counties Gas Company of California, The Department of Water and Power of the City of Los Angeles, and Southern California Edison Company, and an agreement dated October 15, 1969, between Pacific Lighting Service Company, Southern California Gas Company, Southern Counties Gas Company of California, The Department of Water and Power of the City of Los Angeles, Southern California Edison Company, Nevada Power Company, Salt River Project Agricultural Improvement and Power District and Transwestern Pipeline Company, for emergency gas fuel supply to the Mohave electric generating plant in Clark County, Nevada, and

WHEREAS: Pacific Lighting Service Company's participation in such agreements involves relinquishing of gas volumes delivered to Southern California Edison Company and the Los Angeles Department of Water and Power, under Schedule No. G-58, and

WHEREAS: Southern California Edison Company and the Los Angeles Department of Water and Power are parties to both of these agreements; therefore good cause appearing.

IT IS ORDERED that authority be granted under Section X.A. of General Order No. 96-A and Section 491 of the Public Utilities Code for Pacific Lighting Service Company to relinquish gas in accordance with the aforementioned arrangements and be relieved of volumetric obligations to Southern California Edison Company and the Los Angeles Department of Water and Power to the extent necessary to participate in both of these agreements as of October 15, 1969.
