SUBJECT: Order Authorizing Extension of Time for Tracking Authorization

WHEREAS: CALIFORNIA-PACIFIC UTILITIES COMPANY by Advice Letters Nos. 64-G and 64-G Supplement, filed November 27, 1974 and December 10, 1974, respectively, having requested authorization under Sections 454 and 490 of the Public Utilities Code to extend the tracking authorization granted to it by Commission Decision No. 83097 by one additional day and to utilize that one day extension to increase its rates in its South Lake Tahoe rate area, as set forth on Cal. P.U.C. Sheets Nos. 366-G to 368-G, inclusive, in order to track a Southwest Gas Corporation rate increase, effective January 1, 1975, and

WHEREAS: Southwest Gas Corporation made its filing with the Federal Power Commission on November 8, 1974 to increase its rates on gas sold to California-Pacific at South Tahoe, pursuant to its Purchased Gas Adjustment Clause, and

WHEREAS: Southwest's rate increase under this filing is expected to become effective on January 1, 1975 but California-Pacific's authorization to track such an increase, as granted by Decision No. 83097 expires on December 31, 1974, and

WHEREAS: We find that this rate increase is in accordance with the intent and purpose of the tracking provisions of Decision No. 83097; therefore, good cause appearing,

IT IS ORDERED that authority be granted under Sections 454 and 490 of the Public Utilities Code for California-Pacific Utilities Company to extend the tracking authorization granted by Decision No. 83097 to January 1, 1975 and to use such authorization to make the above sheets effective January 1, 1975, conditional upon FPC approval of Southwest's rate increase to become effective that day.

IT IS FURTHER ORDERED that in the event that the FPC fails to authorize Southwest's filing or requires modifications thereof, the above tariff sheets will be marked "Rejected" and that California-Pacific Utilities Company be instructed to submit a new Advice Letter for further consideration of the Commission.

IT IS FURTHER ORDERED that the above tariff sheets be marked to show that they were either issued or rejected, whichever the case may be, under Resolution of the Public Utilities Commission of the State of California No.G-1701.
