SUBJECT: Order Authorizing GEDA Increases in Gas Tariff Schedules

WHEREAS: SOUTHERN CALIFORNIA GAS COMPANY by Advice Letter No. 906, filed November 28, 1974 requests authority under Sections 454 and 701 of the Public Utilities Code to increase rates under the GEDA procedure prescribed by Decision No. 81898 dated September 25, 1973, in Application No. 53625 as set forth on Cal. P.U.C. Sheets Nos. 14035-G to 14050-G, inclusive, to become effective on January 1, 1975, and

WHEREAS: The rate adjustment reflects the gas exploration costs for GEDA Project No. 74-H, Ivan River, previously approved by Resolution No. G-1698, dated November 28, 1974, and

WHEREAS: It is proposed to increase existing tariffs of 0.002 cents per therm resulting in an addition to current annual revenues of approximately \$181,000, and

WHEREAS: The Commission staff is currently proposing revisions to So. Cal.'s Advice Letter No. 905 and such proposed revisions have been presented to the Commission in Resolution No. G-1697, and

WHEREAS: We find that the increase proposed for Advice Letter No. 906 is justified, but the outcome of Resolution No. G-1697 may or may not have an effect on the tariff sheets filed herewith; therefore, good cause appearing,

IT IS ORDERED that in the event the Commission desires to accept Advice Letter No. 905 as filed, without modification, the above tariff sheets, filed with Advice Letter No. 906 will be authorized to become effective on January 1, 1975, under Sections 454 and 701 of the Public Utilities Code and in accordance with the tracking provisions of Decision No. 81898.

IT IS FURTHER ORDERED that in the event the Commission either accepts the staff's recommendations or requires further modification of Advice Letter No. 905, authority will be granted under Sections 491 and 701 of the Public Utilities Code for Southern California Gas Company to file substitute tariff sheets for Advice Letter No. 906 to reflect Commission approved rate levels and that such substitute tariff sheets become effective on January 1, 1975 or upon one-day notice whichever is later.

IT IS FURTHER ORDERED that the above tariff sheets and/or any subsequent substitute tariff sheets be marked to show that they were issued under Resolution of the Public Utilities Commission of the State of California No. 1704.
