SUBJECT: Order Authorizing GEDA Offset Increase in Gas Tariff Schedules on less than Statutory Notice

WHEREAS: SAN DIEGO GAS & ELECTRIC COMPANY by Advice Letter No. 324-G, filed December 4, 1974 requests authority under Section 491 of the Public Utilities Code to adjust its gas rate schedules and Special Contract 186 as set forth on Cal. P.U.C. Sheets Nos. 1773-G to 1783-G, inclusive, to become effective on January 1, 1975, which constitutes less than statutory notice, and

WHEREAS: These tariff revisions are to offset changes in rates filed by Southern California Gas Company in Advice Letters Nos. 905 and 906 for GEDA projects, pursuant to authority granted in Decision No. 81960, dated October 2, 1973, in Application No. 53778, and

WHEREAS: Short notice authorization is requested in order to make this filing coincide with the effective date of So.Cal.'s two filings, and

WHEREAS: The Commission staff is currently proposing revisions to So.Cal.'s Advice Letter No. 905 and such proposed revisions have been presented to the Commission in Resolution No. G-1697, and

WHEREAS: Any revisions to So.Cal.'s Advice Letter No. 905 will affect the tariff sheets presented with So.Cal.'s Advice Letter No. 906 and such a situation has been presented to the Commission in Resolution No. G-1704, and

WHEREAS: The Commission staff is also currently proposing revisions to San Diego's Advice Letter No. 323-G and such proposed revisions have been presented to the Commission by Resolution No. G-1702, and

WHEREAC: We find that the rate increases filed by Advice Letter No. 324-G are in keeping with the intent and purpose of Decision No. 81960, but any one or all of the above factors may have a direct bearing on the tariff sheets filed herewith; therefore, good cause appearing,

IT IS ORDERED that in the event the Commission desires to accept all three Advice Letter filings (So.Cal.'s 905 and 906 and San Diego's 323-G) without modifications, the above tariff sheets, filed with Advice Letter No. 324-G will be authorized to become effective on January 1, 1975, under Section 491 of the Public Utilities Code and in accordance with the tracking provisions of Decision No. 81960.

IT IS FURTHER ORDERED that in the event the Commission either accepts the staff's recommendations or requires further modification by the utility of any one or all of the aforementioned Advice Letters, authority will be granted under Sections 491 and 701 of the Public Utilities Code for San Diego Gas & Electric Company to file substitute tariff sheets for Advice Letter No. 324-G to reflect Commission approved rate levels and that such substitute tariff sheets become effective on January 1, 1975 or upon one-day notice whichever is later.

IT IS FURTHER ORDERED that the above tariff sheets and/or any subsequent substitute tariff sheets be marked to show that they were issued under Resolution of the Public Utilities Commission of the State of California No. G-1705.
