WHEREAS: SOUTHERN CALIFORNIA GAS COMPANY by letter filed June 12, 1975, having requested authority to place a refund plan into effect during July, 1975, and

WHEREAS: The proposed refund plan reflects monies refunded to So. Cal. by El Paso Natural Gas Company in connection with Federal Power Commission settlement agreements and related interest at 7% per annum, and

WHEREAS: The refund plan also includes the balance of funds left unrefunded from the previous refund plan of May, 1974, plus interest at 7% per annum, and

WHEREAS: The total refund amount of \$45,580,055.77 will be refunded to all customers according to class of service and individual usage over specified periods of time, and

WHEREAS: The utility desires to credit such refunds to each customer's July, 1975 bills, and

WHEREAS: We find that this method of refund is acceptable and in the best interest of the customers to have it placed into effect as soon as possible; therefore, good cause appearing,

IT IS ORDERED that authority be granted under Section 491 of the Public Utilities Code for Southern California Gas Company to place the above refund plan into effect commencing July 2, 1975.

IT IS FURTHER ORDERED that Southern California Gas Company shall keep records of the refunds made and shall submit reports to the disposition of any amounts unrefunded by January 1, 1976.
