> SUBJECT: Order Authorizing Decrease in Rates on Less Than Statutory Notice

WHEREAS: PACIFIC GAS AND ELECTRIC COMPANY, by Advice Letter No. 759-G, filed September 24, 1975, requests authority to decrease rates pursuant to the tracking provisions of Decision No. 84119 and pursuant to the rate revision provision of the Canadian-U.S. Monetary Adjustment procedure of Decision No. 83915 as set forth on Cal. P.U.C. Sheets Nos. 9705-G thru 9727-G, and

WHEREAS: PG&E further requests to make the rate reductions therein effective on less than statutory notice under Section 491 of the Public Utilities Code, and

WHEREAS: These tariff sheets will include a reduction in rates from PG&E's supplier, El Paso Natural Gas Company, previously filed in Advice Letter No. 750-G but not yet acted on by the Commission, and

WHEREAS: These tariff sheets will also include a reduction in rates resulting from the Canadian-U.S. Monetary Adjustment procedure, previously filed in Advice Letter No. 750-G but not yet effective, and

WHEREAS: PG&E requests that Advice Letters Nos. 750-G and 755-G be rejected and that this Advice Letter No. 759-G, which combines the rate reductions in the rejected Advice Letters, be made effective on less than statutory notice for service rendered on and after October 1, 1975, and

WHEREAS: Any over-collections that might result from any FPC modification of the El Paso rate reduction indicated in this filing will be included in future refund plans by PG&E, and

WHEREAS: We find that this rate decrease is justified; therefore good cause appearing,

IT IS ORDERED that Advice Letters Nos. 750-G and 755-G be rejected.

IT IS FURTHER ORDERED that authority be granted under Section 491 of the Public Utilities Code and under the provisions of Decision Nos. 84119 and 83915 to make the above tariff sheets in Advice Letter No. 759-G effective for service on and after October 1, 1975.

IT IS FURTHER ORDERED that the above tariff sheets be marked to show that they were issued under Resolution of the Public Utilities Commission of the State of California No. G-1837.

IT IS FURTHER ORDERED that the tariff sheets filed by Advice Nos. 750-G and 755-G be marked to show that they were rejected by Resolution of the Public Utilities Commission of the State of California No. G-1837. I hereby certify that the foregoing Resolution was duly introduced, passed and
