RESOLUTION

SUBJECT: Order Authorizing PGA Offset Increase in Gas Tariff Schedules

WHEREAS: SAN DIEGO GAS AND ELECTRIC COMPANY, by Advice Letter No. 352-G, filed January 22, 1976, having requested authority under Sections 454 and 491 of the Public Utilities Code and under the Purchased Gas Adjustment Clause in its filed tariffs to increase its gas rate schedules as set forth in Cal. P.U.C. Sheets Nos. 1983-G thru 1992-G, and

WHEREAS: Said increase in tariffs is for the purpose of offsetting an increase granted to Southern California Gas Company pursuant to Decision No. 85354 in Application No. 55345, and

WHEREAS: It is proposed to offset the increase by raising the interruptible commodity rates to equal the general service tail block rate, and

WHEREAS: The increase in tariffs will result in an increase in annual revenues to San Diego of approximately \$1,663,400., and

WHEREAS: The increase granted to Southern California by Decision No. 85354 is subject to refund, with seven percent interest, to the extent that a subsequent Decision in Application No. 55345 determines a lower increase, to be reasonable, and

WHEREAS: San Diego's offset increase will be subject to refund at seven percent interest in the same manner, and

WHEREAS: We find that this offset rate increase is reasonable, therefore; good cause appearing,

IT IS ORDERED that authority be granted in accordance with San Diego's Purchased Gas Adjustment Procedure and under Sections 454 and 491 of the P.U.C. Code to make the above tariff sheets effective for service on and after the date the Commission allows Southern California Gas Company to increase its rates pursuant to Decision No. 85354.

IT IS FURTHER ORDERED that this offset increase be subject to refund, with seven percent interest, should the Commission determine a lesser amount to be reasonable, in Application No. 55345.

IT IS FURTHER ORDERED that the above tariff sheets be marked to show that they were issued under Resolution of the P.U.C. of the State of California No. G-1851.
