SUBJECT: Order Authorizing Tracking Rate Revisions in Gas Tariff Schedules

WHEREAS: PACIFIC GAS AND ELECTRIC COMPANY, by Advice Letter No. 773-G, filed March 1, 1976, requests authority pursuant to Decisions Nos. 85305 and 78468 to adjust its rate schedules as set forth on Cal. P.U.C. Sheets Nos. 9785-G thru 9802-G, inclusive, to become effective on April 1, 1976, and

WHEREAS: These tariff revisions are to offset changes filed by El Paso Natural Gas Company under authority of FPC Orders No. 452, et. seq., resulting in a net increase to Pacific Gas and Electric Company, and

WHEREAS: The net result of this filing will be an estimated annual revenue increase of approximately \$11,652,000, notwithstanding any further modifications from El Paso Natural Gas Company, and

WHEREAS: Should the FPC and El Paso Natural Gas Company make further modifications to rates prior to the effective date of this filing, PG&E shall be required, under Sections 491 and 701 of the P.U.C. Code, to submit substitute tariff sheets reflecting such changes in rates, and

WHEREAS: This filing is submitted pursuant to the provisions of Decisions Nos. 85305 and 78468; therefore, good cause appearing,

IT IS ORDERED that authority be granted under Section 454 of the Public Utilities Code and in accordance with the provisions of Decision No. 85305 to make the above sheets effective on April 1, 1976.

IT IS FURTHER ORDERED that in the event that El Paso makes further modification of its April 1, 1976 FPC filing, authority will be granted under Sections 491 and 701 of the Public Utilities Code for PG&E to submit substitute tariff sheets to reflect FPC accepted rate levels, and that such substitute tariff sheets become effective on April 1, 1976, or upon one-day notice, whichever is later.

IT IS FURTHER ORDERED that the above tariff sheets and/or any subsequent substitute tariff sheets be marked to show that they were issued under Resolution of the Public Utilities Commission of the State of California No. G-1864.
