SUBJECT: Order Authorizing Decrease For Steam Tariff Rates

WHEREAS: SAN DIEGO GAS AND ELECTRIC COMPANY, by Advice Letter No. 93-H, filed March 2, 1976, requests authority to decrease its steam tariff rates, as set forth on Cal. P.U.C. Sheets Nos. 305-H to 307-H, inclusive, in accordance with the procedure provided for in Section 7. of the Preliminary Statement, and

WHEREAS: The total net revenue effect of this requested filing will mean approximately \$6,900 annual decrease for the utility's Steam Department, and

WHEREAS: The requested decrease is based on a proposed systemwide average fuel cost of 231.34¢ per M² Btu for San Diego's Electric Department, which was filed on March 2, 1976, by Advice Letter No. 403-E, and

WHEREAS: It is the staff's recommended procedure to base steam fuel cost adjustments on the same basis as the latest approved electric fuel cost adjustment factor, and

WHEREAS: The Commission, in adopting the fuel cost adjustment for San Diego's Electric Department, in Advice Letter No. 403-E, may determine that a systemwide electric fuel cost other than 231.34¢ per M² Btu is appropriate; therefore, good cause appearing,

IT IS ORDERED that San Diego Gas and Electric Company be authorized to place into effect a revised steam fuel cost adjustment billing factor based on the same systemwide electric fuel cost as adopted by the Commission for Advice Letter No. 403-E.

IT IS FURTHER ORDERED that the subject steam tariff sheets be effective on and after the same date that is authorized by the Commission for the electric preliminary statement to become effective, or on April 1, 1976, whichever is later.

IT IS FURTHER ORDERED that the subject steam tariffs be marked to show that they were issued under Resolution of the Public Utilities Commission of the State of California No. G-1867.
