R E S O L U T I O N

SUBJECT: Order Authorizing PGA Offset Increase in Gas Tariff Schedules

WHEREAS: SOUTHWEST GAS CORPORATION, by Advice Letter No. 161, filed June 30, 1976 requests authority under the Purchased Gas Adjustment Clause in its filed tariffs, to adjust its gas rate schedules as set forth on Cal. P.U.C. Sheets Nos. 1203-G to 1211-G, inclusive, to become effective August 1, 1976, and

WHEREAS: These tariff revisions are to offset changes in rates requested by PG&E in Application No. 56392, and

WHEREAS: Southwest Gas Corporation was granted a PGA procedure by Decision No. 84603, dated July 1, 1975, in Application No. 54807, and

WHEREAS: Southwest proposes to establish lifeline quantities at 75 therms pending final determination of lifeline by the Commission in Case No. 9988, and

WHEREAS: It is proposed to increase existing tariffs to result in an addition to current annual revenues of approximately \$256,476, and

WHEREAS: We find this rate increase to be reasonable; therefore good cause appearing,

IT IS ORDERED that authority be granted in accordance with the provisions of Southwest Gas Corporation's Purchased Gas Adjustment procedure and under Section 454 of the Public Utilities Code to make the above tariff sheets effective for service on August 1, 1976 or on the same date that the Commission allows PG&E's rate increase to be effective, whichever is later.

IT IS FURTHER ORDERED that in the event that PG&E is required to file different tariffs other than those contained in Application No. 56392, authority will be granted under Sections 491 and 701 of the Public Utilities Code for Southwest to submit substitute tariff sheets to reflect Commission approved rate levels and that such substitute tariff sheets will become effective August 1, 1976, or on one-day notice, whichever is later.

IT IS FURTHER ORDERED that the above tariff sheets and/or any subsequent substitute tariff sheets be marked to show that they were issued under Resolution of the Public Utilities Commission of the State of California No. G-1925. The effective date of this resolution is the date hereof.
