SUBJECT: Order Authorizing PGA Rate Increase

WHEREAS: SOUTHERN CALIFORNIA GAS COMPANY, by Advice Letter No. 1031, filed November 17, 1976, having requested authority under the PGA clauses of the utility's filed tariffs, to file revised tariff sheets in order to track rate increases by its suppliers, El Paso Natural Gas Co., Transwestern Pipeline Co., and Pacific-Interstate Transmission Co., as set forth on Cal. P.U.C. Sheets Nos. 14701-G to 14716-G, inclusive,

WHEREAS: The proposed revenue revision of \$24,191,000 will offset the proposed rate increases by El Paso, Transwestern, and Pacific-Interstate, and

WHEREAS: An effective date of December 1, 1976 is requested in order to coincide with the anticipated effective dates of the increases from the suppliers, and

WHEREAS: This filing is made pursuant to the PGA clauses of the utility's filed tariff schedules, except for the short notice authorization, and

WHEREAS: In the event that the FPC should approve rate schedules different from that requested by any or all of the above suppliers or require different effective dates, SoCal will file substitute tariff sheets to reflect approved rate levels, and

WHEREAS: We find this rate increase to be reasonable; therefore, good cause appearing,

IT IS ORDERED that Southern California Gas Co. be granted authority under Sections 454, 491 and 701 of the Public Utilities Code, and under the provisions of the PGA clause of its filed tariff schedule to place the above tariff sheets or subsequent substitute tariff sheets into effect on December 1, 1976, or on a date concurrent with the effective date of FPC approved rate increases, whichever date is later.

IT IS FURTHER ORDERED that the above tariff sheets and/or any subsequent substitute tariff sheets be marked to show that they were issued under Resolution of the Public Utilities Commission of the State of California No. G-1991. The effective date of this Resolution is the date hereof.
