SUBJECT: Order Authorizing Acceptance of Special Contract Under Conditions Deviating from Filed Tariffs

WHEREAS: SOUTHERN CALIFORNIA GAS COMPANY, by Advice Letter No. 1038, filed December 15, 1976, having requested authority under Sections 454, 491 and 532 of the Public Utilities Code and under the provisions of Decision No. 85189 to carry out the terms and conditions of a special contract with Weiser Company (Applicant), covering a gas main extension and supply of additional natural gas service in excess of 50 Mcfd and under conditions that deviate from filed tariffs, and

WHEREAS: Applicant is consolidating several small plant operations at a new location in Huntington Beach, Orange County, transferring its existing gas loads and adding new equipment, thus increasing the average daily consumption by 307 Mcf, from 181 Mcf to 488 Mcf, and

WHEREAS: The contract for said gas main extension deviates from filed tariffs in that the cost of construction will be borne by the customer without allowing one year's estimated revenue to be deducted from the advance as provided by Rule No. 21, and that should the customer fail to take service within six months after the utility is ready to render service, the customer will be obligated to pay a cost-of-ownership charge equal to 1% of the advance until service is rendered or for a period of sixty months, whichever comes first, and

WHEREAS: The reason for such deviations is because sales of additional gas to this customer will result in no significant additional revenue to the utility under current supply conditions, and

WHEREAS: Applicant's new equipment does not have alternate fuel capability and will be classified as Priority 2A under the end-use criteria adopted in Decision No. 85189, and

WHEREAS: Short notice authorization is requested in order to commence construction of the gas main extension on a timely basis, and

WHEREAS: We find this contract to be reasonable and in the best interest of all concerned; therefore, good cause appearing,

IT IS ORDERED that authority be granted under Sections 454, 491 and 532 of the Public Utilities Code and under the provisions of Decision No. 85189 for Southern California Gas Company to provide the additional facilities and to provide the additional natural gas service to Weiser Company, effective this date.

IT IS FURTHER ORDERED that the above contract and advice letter be marked to show that they were accepted for filing under Resolution of the Public Utilities Commission of the State of California No. G-2019. The effective date of this resolution is the date hereof
