SUBJECT: Order Authorizing Acceptance of New Sample Forms Resulting in More Restrictive Condition

WHEREAS: PACIFIC GAS & ELECTRIC COMPANY, by Advice Letter No. 896-G, filed April 1, 1977, having requested Commission approval under Section VA of General Order No. 96-A to file new and revised sample forms as set forth on Cal. P.U.C. Sheets Nos. 10171-G to 10174-G, inclusive, and resulting in the following:

- 1. New Sample Form No. 62-3404-Gas Use Violation and revised Sample Form No. 62-4112 (4/76)-Statement of Account are presented for filing in the utility's filed tariffs.
- 2. The notice of Gas Use Violation is to be used in the enforcement of Rule No. 14.1 and will provide the utility with a means of notifying customers that their use of gas includes prohibited use and that their gas service is subject to termination unless they initiate compliance with Rule No. 14.1.
- 3. Rule No. 14.1 was filed in compliance with Decision No. 87017 in Case No. 9642 and became effective on February 28, 1977 as an interim emergency order listing prohibitions and curtailment provisions on natural gas use.
- 4. Sample Form No. 62-3404 will create more restrictive conditions to some customers by enforcing the provisions of the interim emergency order. The revisions to Sample Form No. 62-4112 (4/76) are minor in nature and will result in no change in the application of rules and tariffs.
- 5. We find that the gas supply situation is critical, thus requiring enforcement of the provisions of Rule No. 14.1; therefore, good cause appearing,

IT IS ORDERED that:

- 1. Authority be granted under Section 454 of the Public Utilities Code for PG&E to place the above tariff sheets into effect on May 1, 1977, which constitutes regular statutory notice.
- 2. The above tariff sheets be marked to show that they were authorized under Resolution of the Public Utilities Commission of the State of California No. G-2069. The effective date of this resolution is the date hereof.
