SUBJECT: Order Authorizing Revision of Filed Steam Tariffs
 Resulting in Rate Increase

WHEREAS: SAN DIEGO GAS & ELECTRIC COMPANY by Advice Letter No. 96-H, filed May 27, 1977, requests authority under Section 454 of the Public Utilities Code to increase its steam tariff rates, in accordance with the Energy Cost Adjustment Clause (ECAC) provisions of its Preliminary Statement, as set forth on Cal. P.U.C. Sheets Nos. 319-H to 321-H, inclusive, and resulting in the following:

1. The total net revenue effect of this request will result in an annual revenue increase of \$123,500, or 6.5%, for the utility's Steam Department.
2. The ECAC adjustment rates is changed from \$1.19 per M lbs. to \$1.72 per M lbs. of steam for Schedule 1 and from \$1.21 per M lbs. to \$1.74 per M lbs. of steam for Schedule 2.
3. Reflected in the proposed steam ECAC adjustment rates is the utility's proposed Schedule G-54 gas rate of 251.56¢ per M² Btu as requested by Advice Letter No. 390-G.
4. An effective date of July 1, 1977 is requested in keeping with the utility's announced policy of making ECAC adjustment rates on January 1, and July 1 of each year.
5. In the event that the Commission should authorize, on or before July 1, 1977, Schedule G-54 rates different than those currently proposed in Advice Letter No. 390-G, or if such rates take effect on a date after July 1, 1977, the utility will file revised tariff sheets to reflect a steam ECAC rate adjustment based on Schedule G-54 rates actually in effect on July 1, 1977.
6. This rate schedule revision and resultant rate increase is found to be reasonable; therefore, good cause appearing,

IT IS ORDERED that:

1. Authority be granted under Sections 454, 491 and 701 of the Public Utilities Code for San Diego Gas & Electric Company to place the above tariff sheets and/or any subsequent substitute tariff sheets into effect on July 1, 1977.
2. The above tariff sheets and/or substitute tariff sheets be marked to show that they were authorized under Resolution of the Public Utilities Commission of the State of California No. G-2101. The effective date of this Resolution is the date hereof.
