SUBJECT: Order Authorizing Revision of Tariff Schedules to Create
New Rate Schedules Involving Increased Revenues

WHEREAS: PACIFIC GAS & ELECTRIC COMPANY, by Advice Letter No. 948-G, filed October 28, 1977, having requested authority to file revised tariff schedules, to include a rate schedule applicable to swimming pools and another rate schedule applicable to Priority 2A customers, as set forth on Cal. P.U.C. Sheets Nos. 10253-G to 10258-G, inclusive, under the following conditions:

1. The new rate schedules are a result of Decisions Nos. 87192, 87516 and 87784 in Case No. 9642 et. al.
2. Schedule G-1SN-Natural Gas Service-Commercial, Swimming Pool Service was established for all new municipal, school or commercial swimming pool heating, classified as Priority P1, P2-A or P2-B.
3. Schedule G-50T-Natural Gas Service was established for those customers, classified as Priority 2-A (temporary) who have not met the deadline of December 2, 1977 for installing adequate standby equipment and transfer to a lower priority.
4. Customers transferred to Schedule G-50T will receive the same increase in commodity rate of 1.0 cent per therm that they would have received as Priority P3 or P4 customers, plus an additional surcharge of 7.1 cents per therm after customers in Priorities P3 and P4 have been curtailed.
5. The additional charge for deliveries during periods of P3 or P4 curtailment shall not be less than the equivalent cost of No. 2 fuel oil and is anticipated to increase annual revenue by \$9,000, which will be credited to the Gas Cost Balancing Account.
6. We find these rate revisions to be reasonable and allows for equitable rates for all customers; therefore, good cause appearing,

IT IS ORDERED that:

1. Authority be granted under Section 532 of the Public Utilities Code for Pacific Gas & Electric Company to place the above tariff sheets into effect on November 28, 1977, which constitutes regular statutory notice.
2. The above tariff sheets be marked to show that they were authorized for filing under Resolution of the Public Utilities Commission of the State of California No. G-2164. The effective date of this resolution is the date hereof.
