SUBJECT: Order Authorizing the Temporary Reclassification of Priority for a  
Nonresidential Customer

WHEREAS: SOUTHERN CALIFORNIA GAS COMPANY, by Advice Letter No. 1110, filed November 23, 1977, having requested Commission approval under the provisions of Decision No. 85189, to temporarily reclassify Latchford Gas Company (Applicant), in Los Angeles, Los Angeles County, from Priority 3 to Priority 2A (temporary) under the following conditions:

1. Applicant purchased its glass manufacturing plant from Anchor Hocking in April 1, 1977.

2. At the time of sale, Anchor Hocking was operating one glass furnace (long overdue for overhaul) as Priority 2A (temporary) under a deviation authorized by Commission Resolution No. G-2048 since oil firing would significantly increase the probability of collapse of essential portions of the furnace.

3. Anchor Hocking was to repair another furnace for oil firing by July 1, 1977 (the expiration date of Resolution No. G-2048), at which time the furnace in question could be shut down, but Anchor Hocking did not take the steps necessary for repair work because of the pending plant sale to Applicant.

4. Since Anchor Hocking failed to correct the conditions which led the Commission to grant the original deviations, SoCal now requests the Commission to authorize for Applicant reclassification of the same furnace to a higher classification until March 1, 1978, when Applicant will shut down the furnace for the necessary repairs.


5. We find that this request should be granted, and that the Applicant should be classified as Priority 2A (temporary) until March 1, 1978 under the end-use criteria adopted in Decision No. 85189; therefore, good cause appearing,

IT IS ORDERED that:

1. Authority be granted under the provisions of Decision No. 85189 for Southern California Gas Company to supply the requested service to Latchford Glass Company until March 1, 1978 effective December 23, 1977.

2. The above advice letter and application be marked to show that they were authorized for filing under Resolution of the Public Utilities Commission of the State of California No. G-2180. The effective date of this Resolution is the date hereof.
