RESOLUTION

RETURN TO GAS BRANCH

SUBJECT: Pacific Gas & Electric Company. Order Authorizing Acceptance of Special Contract Under Conditions Deviating From Filed Tariffs.

WHEREAS: PACIFIC GAS & ELECTRIC COMPANY (PG&E), By Advice Letter No. 1051-G, filed September 4, 1979, having requested authorization to carry out the terms and conditions of a special contract with Hi-Tech Industrial Development (Hi-Tech), covering a gas main and distribution extension to provide natural gas service to Hi-Tech's commercial and industrial development in Oakdale, Stanislaus County, under the following conditions:

- 1. The agreement deviates from filed tariffs in that Hi-Tech will pay in advance of construction a refundable amount of \$13,623.08, which represents the total cost of the gas system (\$15,560) less \$1,936.92 for the credit of the trenching to be performed by the developer.
2. The agreement further deviates from filed tariffs by requiring a cost-of-ownership fund of \$11,476.08 representing the present worth of the annual costs to PG&E equal to 12% of the Gas Extension Advance at 7% interest for a period of 10 years.
3. In the event that refunds are made on the advance, the cost-of-ownership fund will be adjusted accordingly.
4. Hi-Tech desires the gas facilities for an industrial park development and is not the ultimate consumer of gas. It is not yet determined who the ultimate consumers will be.
5. This agreement is similar in context to the agreement filed by Advice Letter No. 1045-G, and authorized by Commission Resolution No. G-2289 on July 3, 1979, and


WHEREAS: We find that this agreement is compensatory and nondiscriminatory and will provide service to applicant in such a manner as to not place a burden on other ratepayers; therefore, good cause appearing,

IT IS ORDERED that:

- 1. Authority is granted under Sections 454 and 532 of the Public Utilities Code to place this contract in effect on October 4, 1979, which constitutes regular statutory notice.
2. The above advice letter and contract be marked to show that they were accepted for filing under Resolution No. G-2307 of the Public Utilities Commission of the State of California. The effective date of this Resolution is the date hereof.
