set forth on Cal. P.U.C. Sheets Nos. 15509-G to 15518-G, inclusive, under the following conditions:

- 1. The revisions to the service agreement are made to conform to recent Commission decisions on parity of service, end-use priorities and own-source gas supplies, as well as reflecting the Commission's expressed desires for simplification and consistency.
- 2. The revision provides for parity of service in each end-use priority at the practical equivalent of levels of service provided to retail and other wholesale customers in parallel priorities.
- 3. The agreement also provides for levels of service in accordance with the Commission's end-use priorities as set forth in Rule No. 23 of the utility's filed tariff schedules.
- 4. The agreement further provides for gas supplies to be in accordance with the Commission's Decision No. 87510 on own-source gas, issued June 28, 1977 in Case No. 9642.
- 5. With regards to rates, the revised rate schedule has reduced the complexity of the rate to a straight two-part rate; monthly capacity charge and a unit commodity charge.
- 6. The utility alleges that there will be no increase in revenues arising from these charges, nor will it cause the withdrawal of service or conflict with other rate schedules or rules.
- 7. The utility will file substitute tariff sheets should Commission action on other pending matters make it necessary, and

WHEREAS: An effective date of December 1, 1979 is requested to coincide with the anniversary date of the Long Beach Service Agreement; therefore, good cause appearing.
