SUBJECT: San Diego Gas & Electric Company. Order Authorizing Revisions to Steam Tariff Rules to Eliminate Provisions Previously Approved by Commission Order.

WHEREAS: SAN DIEGO GAS & ELECTRIC COMPANY (SDG&E), by Advice Letter No. 110-H, filed February 1, 1980, requests authority under Section V.A. of General Order No. 96-A, to revise Rule No. 14.1 of the utility's filed Steam Tariffs, as set forth on Cal. P.U.C. Sheets Nos. 401-H to 403-H, inclusive, under the following conditions:

1. Rule No. 14.1 - Interim Emergency Order, Prohibitions, Conservation and Curtailment Provisions, was added to the utility's steam tariffs on October 18, 1979 by Advice Letter No. 108-H in order to conform to similar rules in the utility's Gas and Electric Tariffs.

2. One of the original provisions of the Rules Nos. 14.1 of the Gas Tariffs and 14.1 of the Electric Tariff was that energy should not be used in commercial or industrial establishments to provide heat in excess of 65°F, except where other temperatures are specifically required by law, or for health reasons.

3. This maximum temperature setting was established on February 7, 1977 by Decision No. 86932 and was later amended to 68 F on November 17, 1978 by Decision No. 89589.

4. On January 8, 1980, by Decision No. 91184, the Commission again amended Rule 14.1 for Gas Tariffs and Rule 14.1 for Electric Tariffs by deleting any reference to a maximum temperature setting.

5. The Commission order, however, was silent on the subject of Steam tariffs, and

WHEREAS: We find that it is reasonable for Rule 14.1 of the Steam Tariffs to be consistent with the corresponding rules in the Gas and Electric Tariffs; therefore, good cause appearing,

IT IS ORDERED that:

1. Authority be granted under Section V.A. of General Order No. 96-A and under the provisions of Decision No. 91184 for San Diego Gas & Electric Company to place the above tariff sheets into effect on March 2, 1980, which constitutes regular statutory notice.
