RETURN TO GAS BRANCH

SUBJECT: Pacific Gas & Electric Company, Gas Department. Order Authorizing Acceptance of a Special Contract Under Conditions Deviating from Filed Tariffs.

WHEREAS: PACIFIC GAS & ELECTRIC COMPANY (PG&E), by Advice Letter No. 1122-G, filed November 25, 1980, has requested authority to carry out the terms and conditions of a special contract with K & L Industrial Park, covering a gas main extension and service stubs to provide natural gas service to applicant's commercial and industrial development in Fresno, Fresno County under conditions deviating from filed tariffs and resulting in the following:

1. The agreement deviates from filed tariffs in that the applicant will pay in advance of construction \$29,768, which represents the total cost of the system (\$38,560) less a credit of \$8,792 for trenching and backfilling to be performed by applicant.
2. The agreement further deviates from filed tariffs in that the applicant will pay PG&E a monthly cost-of-ownership charge of \$385, which represents 1% of the total cost of the gas system, and will be adjusted accordingly if refunds are made.
3. The applicant is constructing a commercial and industrial development and is not the ultimate consumer of gas service to be provided.
4. Since not all of the ultimate consumers have been determined at this time, exercising the Exceptional Case clause of Rule No. 15 is appropriate in this case.
5. The agreement is basically similar in content with prior agreements filed by PG&E and authorized by prior Commission Resolutions; most recent of which was Resolution No. G-2380 on October 22, 1980, and

WHEREAS: We find that this agreement is compensatory and nondiscriminatory and will provide service to applicant in such a manner as not to place a burden on other ratepayers; therefore, good cause appearing,


IT IS ORDERED that:

RETURN TO GAS BRANCH

1. Authority is granted under Section X.A. of General Order No. 96-A and under Section 454 and 532 of the Public Utilities Code to place the above contract into effect on December 25, 1980, which constitutes regular statutory notice.
2. The above advice letter and contract shall be marked to show that they were accepted for filing under Resolution No. G-2395 of the Public Utilities Commission of the State of California. The effective date of this resolution is the date hereof.
