RESOLUTION**RETURN TO GAS BRANCH**

SUBJECT: San Diego Gas & Electric Company. Order Authorizing
Acceptance of Gas Refund Plan.

WHEREAS: SAN DIEGO GAS & ELECTRIC COMPANY (SDG&E), by letter dated January 12, 1981, has requested authority to place a Gas Refund Plan into effect under the following conditions:

1. The proposed refund reflects funds to be received from SDG&E's supplier, Southern California Gas Company, (SoCal) in February, 1981, pursuant to Commission Resolution No. G-2389, dated December 16, 1980.

2. The refundable amount, including accrued interest to February, 1981, is approximately \$16,100,000, which averages, \$13.00 per residential customer and \$63.00 per commercial customer.

3. The refund reflects overcollections for two separate periods of time ranging from October, 1975 to August, 1980.

4. Refunds to residential and commercial customers will be allocated to each customer reflecting the sales to that customer during the 12 month period ending January, 1981 or portion thereof and will be based upon the total refundable amount for the two refund periods.

5. Refunds to industrial customers will be allocated to each customer reflecting the actual sales to that customer in each of the refund periods and are based on the actual refundable amounts in each of the respective time periods with the total amount being the sum of the two refunds.

6. Refunds to eligible active customers will be reflected as a credit to their February 1981 bills, with refund checks being mailed to eligible former industrial customers.

7. Refunds are not contemplated for former residential customers, however, SDG&E will evaluate all requests from customers or former customers, through July 1981, who either did not receive a refund or who contend that the refund should be larger, and will make adjustments where deemed appropriate.

8. The utility shall notify all customers receiving a refund that the refund was made pursuant to an order of this Commission, and

WHEREAS: We find this refund plan to be acceptable; therefore, good cause appearing,

IT IS ORDERED that:

1. Authority is granted under Section 453.5 of the Public Utilities Code for San Diego Gas & Electric Company to place the above refund plan into effect during the month of February, 1981.



2. San Diego Gas & Electric Company shall keep records of the refunds and shall submit reports on the disposition of any amounts unrefunded by November 1, 1981.

3. The above refund plan shall be marked to show that it was approved for filing by Resolution No. G-2410 of the Public Utilities Commission of the State of California. The effective date of this resolution is the date hereof.
