Southwest Gas Corporation. Order Authorizing Extension of Time to File Report on Refund Plans as Directed by Prior Commission Order.

WHEREAS: SOUTHWEST GAS CORPORATION (SoWest), by letter dated February 5, 1981, filed a "Petition For An Extension of Time to Submit a Final Report" with respect to Gas Refund Plans Nos. 13 and 14, with the following provisions:

- 1. Gas Refund Plans Nos. 13 and 14 were approved for filing and were placed in effect by Commission Resolution No. G-2358, dated July 2, 1980.
- 2. Gas Refund Plan No. 13 was placed into effect during the month of July, 1980 and Refund Plan No. 14 in October of 1980.
- 3. Ordering Paragraph No. 2 of Commission Resolution No. G-2358 directed Sowest to submit reports on the disposition of any amounts unrefunded by no later than January 1, 1981.
- 4. By the above petition, SoWest alleges that it has not concluded its accounting for the calendar year 1980, and is therefore unable to comply with the time constraints contained in the Resolution.
- 5. In view of the above SoWest requests an extension of time to March 31, 1981, in which to submit its final report on the disposition of any amounts unrefunded, and

## IT IS ORDERED that:

1. Authority is granted under Sections 453.5, 701 and 1708 of the Public Utilities Code to amend Ordering Paragraph 2 of Commission Resolution No. G-2358 to require Southwest Gas Corporation to file reports on the final disposition of funds unrefunded in Gas Refund Plans Nos. 13 and 14 by no later than March 31, 1981.
