

FOUR CORNERS PIPE LINE COMPANY (FCPL) hereby submits for filing the following tariffs which govern the gathering and/or transportation of crude petroleum and indirect liquid products of oil and gas wells by pipeline.

The purpose of this filing is to submit proposed tariff rate changes which reflect an increase in rates of 5% for all current California P.U.C. tariffs. FCPL has maintained tariff rates at 1983 levels for five years.

FCPL proposes this change to offset a 17% decline in revenue from 1987 to year-end projections for 1988 due to decreased volumes; combined with a 10% increase in operating expenses due to inflation, permitting and maintenance costs of the pipeline system.

Effective January 1, 1989, at present volumes, current tariffs reflecting a 5% rate increase are estimated to increase FCPL's revenue by approximately \$1.1 million.

Anyone who wishes to protest this letter may do so by sending a letter <u>within 20 days</u> of the date of this filing. The protest should be mailed to: Mr. Dean J. A copy of the letter should also be mailed to: 1) Jeffrey P. O'Donnell, Chief, Energy Branch, California Public Utilities Commission; and 2) the undersigned. The protest shall set forth specificially the grounds upon which the protest is based, including such items as financial and service impact. There is no restriction on who may file a protest.
