COMMENTS OF DUKE ENERGY NORTH AMERICA REGARDING DRAFT GENERAL DUTY STANDARDS RESOLUTION

Pursuant to the schedule established in the April 16, 2003 document of the California Electricity Generation Facilities Standards Committee (Committee), Duke Energy North America (DENA) respectfully submits these comments on the Draft General Duty Standards Resolution (Draft Resolution).

COMMENTS

DENA has reviewed the "General Duty Standards" (GDS) included as

Attachment A of the Draft Resolution. DENA has no current specific criticism of the
document per se; it appears to merely reiterate provisions of SB 39xx and involves
nothing inconsistent with DENA's standard practices with respect to its facilities.

However, given the GDS' explicit and necessary caveat that nothing in the GDS shall
modify, delay or abrogate other regulatory requirements, and in light of the Committee's
stated intention to develop a set of operating standards sometime in the future, it is
unclear what purpose the Draft Resolution or GDS serve. Moreover, there is nothing
apparent in the broad, generalized policy statement found in the GDS that could involve
any required implementation or enforcement.
