Dear Commissioners:

On February 17 and 18, 2005, the California Public Utilities Commission, California Energy Commission and other entities, will convene a technical conference to discuss natural gas quality and natural gas interchangeability issues. Crystal Energy LLC ("Crystal") submits these pre-workshop comments pursuant to the "Notice of Workshop on Natural Gas Quality Issues" issued on December 23, 2004.

Crystal Energy, LLC is in the process of seeking the permits necessary to construct and operate the Crystal Clearwater Port project. The Crystal Clearwater Port project is located about 13 miles offshore Ventura County, California. The cooled natural gas will be transported by ship to a platform, where it will be converted back into vapor form useful to California natural gas customers. The natural gas will be delivered from the platform to shore in a state of the art pipeline using an existing pipeline corridor. It will then come onshore at an existing industrial facility before entering the Southern California Gas Company (SoCal Gas) pipeline system. The natural gas will provide Ventura County and California with a clean, secure and abundant source of energy that will help meet the state's energy needs well into the future.

Crystal is supportive of industry and governmental efforts to identify gas quality specification that will help ensure a consistent and reliable supply for all natural gas customers.

Crystal will only import natural gas that will meet the specifications of the California Air Resources Board ("CARB"). Crystal does not request any changes to current gas quality specifications contained in the CARB regulations.

As for any possible future changes to natural gas specifications, Crystal wants to reiterate that natural gas suppliers value certainty and stability. The quality specifications for natural gas should be clearly articulated and consistently applied to all suppliers. Any proposed changes should be discussed in an open public process that provides full notice and an opportunity to be heard by all affected parties. LNG suppliers utilizing Crystal's Clearwater Port to provide a long term, low cost, reliable and safe natural gas supply to California will make substantial investments to ensure compliance with the applicable quality specifications. Changes in gas quality standards that are swift or capricious undermine the certainty and stability necessary for a vigorous and well-functioning gas market. Accordingly, the consideration of possible changes in natural gas quality standards, if necessary, should have as its hallmark close consultation with all potentially affected parties and an open, public process, as is the tradition and practice of your agencies. Crystal is committed to continuing to be an active and productive participant in any proceedings regarding natural gas specifications.

Crystal appreciates the opportunity to submit comments on these gas quality and interchangeability issues.
