APPLICATION FOR NOMINATION

DIRECTIONS

- I. Pursuant to the Diablo Canyon Power Plant settlement agreement, applications by persons qualified to serve on the Independent Safety Committee and CPUC Decision D.97-05-088 created by the settlement agreement are being solicited by the nominators of the Committee. The nominators are Pacific Gas and Electric Company (PG&E), represented by its President, Gordon R. Smith; Richard A. Bilas, President of the California Public Utilities Commission (CPUC); and Paul R. Gray, Dean of Engineering of the University of California at Berkeley.

The Diablo Canyon settlement was agreed to in 1988 by California Attorney General John Van de Kamp, the CPUC's Division of Ratepayer Advocates, and PG&E, and was unanimously approved by the CPUC on December 19, 1988 (Decision No. 88-12-083). CPUC Decision 97-05-088 terminated the settlement, but extended one of the provisions of the settlement which provides for a three-member Independent Safety Committee, to be selected by the Governor, state Attorney General, and the Chairman of the California Energy Commission. The selection is to be made from a list of nominees jointly provided by PG&E, the President of the CPUC, and the Dean of Engineering of the University of California at Berkeley.

The purpose of the Independent Safety Committee is to review Diablo Canyon operations for the purpose of assessing the safety of operations and suggesting any recommendations for safe operation. The committee is required to submit an annual report of its observations and recommendations first to PG&E, and then to the governor, the CPUC, the Attorney General, and the California Energy Commission, along with PG&E's response.

The settlement provides that only persons with knowledge, background, and experience in the field of nuclear power facilities are eligible to be considered for membership on the Committee. In addition, members of the Committee must meet conflict of interest and financial disclosure standards similar to those applicable to public officials. For these reasons, applicants for membership on the Committee will be required to demonstrate their qualifications and disclose their personal finances on a confidential basis in order to be eligible for nomination. Persons who wish to apply for membership on the Independent Safety Committee must complete this application and submit it to the nominators. - II. To be considered, the application must include specific supporting information requested below demonstrating that the prospective nominee possesses the requisite qualifications to serve on the Committee. Applications will be considered in strict confidence, but receipt will be acknowledged.

- III. An application may be rejected or not considered if it is conditional or incomplete in any manner. The nominators reserve the sole discretion to determine the process for reviewing and considering applications consistent with the requirements of the Settlement Agreement. Applicants may be required to provide additional information concerning their qualifications beyond that provided in this application in order to be considered for nomination to the Independent Safety Committee.

It is mandatory that applications contain the signature of the applicant. Applications without such a signature will not be considered.

Each person should have the requisite technical expertise to review Diablo Canyon operations for the purpose of assessing the safety of operations and suggesting any recommendations for safe operation (Settlement Agreement, Attachment A, paragraph (1)). Please provide on separate sheets of paper, in reverse chronological order:

- I. A list of all positions and employment held in the field of nuclear power facilities;
- II. A description of all technical experience in the field of nuclear power facilities;
- III. A list, with representative copies attached, of all publications in the field of nuclear power facilities;
- IV. A detailed explanation of how such positions, employment, experience, and/or publications qualify you for membership on the Independent Safety Committee; and
- V. A list of references, at least three of which are not former employers or supervisors.
