Re: General Order 88-B Request for Authority to Alter the Washington Street Highway-Rail Crossing, CPUC Crossing No. 005-38.60, DOT No. 498688E, in the City of Petaluma, Sonoma County

Dear Mr. Anderson:

This refers to your letter received by us on July 22, 2010 requesting authorization by the North Coast Railroad Authority (NCRA), pursuant to Commission General Order (GO) 88-B, to alter an at-grade highway-rail crossing of the Sonoma-Marin Area Rail Transit (SMART) track in the City of Petaluma, County of Sonoma. The crossing is identified as Washington Street Highway-Rail Crossing, CPUC Crossing No. 005-38.60, DOT No. 498688E.

The crossing is currently a single track crossing equipped with three Commission Standard 9 (flashing light signal assembly with automatic gate arm) warning devices. At this location, Washington Street is a five-lane road running generally north/south. There is currently no rail service at this crossing. However, freight rail service is expected to begin in Fall 2010, running approximately 6 trains per week at a maximum speed of 45 mph.

The proposed alteration as indicated in the request letter and/or shown in the attachments shall consist of:

- Replacing the existing warning devices and track circuitry.
- The existing two Commission Standard 9 warning devices for eastbound traffic shall be replaced with new curb-mounted Commission Standard 9-A (flashing light signal assembly with automatic gate arm and additional flashing light signals over the roadway on a cantilevered arm) and a new Commission Standard 9 in the median.
- The existing median shall be widened to accommodate clearance requirements for the new warning device.
- A Commission Standard 9 shall be installed in a pork chop island in the northeast quadrant for westbound traffic on Washington Street.

- A CAMUTCD R3-2 “No Left Turn” blank out sign will be installed for northbound traffic and a R3-1 “No Right Turn” blank out sign will be installed for southbound traffic on Lakeville Street.
- A Commission Standard 8 (flashing light signal assembly) shall be installed in the northwest quadrant for bikes and pedestrians with an extra set of flashers directed toward traffic on eastbound Lakeville Street, which runs parallel to the tracks at this location.
- All warning devices shall be outfitted with 12” LED flashers.
- Detectable warning tactile strips are to be placed on all sidewalk approaches to the crossing. Detectable warning to be three feet in the direction of travel across the entire pedestrian pathway, with the edge nearest the tracks placed 1 – 2 feet in advance of the adjacent warning device, where present, but no closer than 12 feet from the nearest rail in all quadrants.
- The new crossing circuitry shall consist of an HXP-3R constant warning time predictor and have a pre-emption interconnection with the intersection traffic signals.

NCRA states in its GO88-B request letter that the project will improve public safety.

Staff has investigated NCRA’s request, and finds it adequately addresses compliance and safety. As NCRA, SMART and the City of Petaluma are in agreement as to the design and apportionments of the cost under the provisions of GO 88-B, you may proceed with the improvements as described in your request letter and attachments, and summarized above.

Temporary traffic controls shall be provided in compliance with section 8A.05, Temporary Traffic Control Zones, of the California Manual on Uniform Traffic Control Devices (CA MUTCD), published by the California Department of Transportation.

All parties shall comply with all applicable rules, including Commission General Orders and CA MUTCD.

This project is categorically exempt from the requirements of the California Environment Quality Act of 1970, as amended [California Public Resources Code 21084].

This authorization shall expire if the above conditions are not complied with or if the work is not completed within two years of the date of this letter. Upon written request to this office, the time to complete the project may be extended. Any written request for a time extension must include concurrence letters by involved parties in support of the time extension. If an extension is requested, the Commission’s Rail Crossings Engineering Section (RCES) may reevaluate the crossing prior to granting an extension.

Within 30 days after completion of this project, NCRA shall notify RCES that the authorized work is completed, by submitting a completed Commission Standard Form G titled *Report of Changes at Highway Grade Crossings and Separations*. Form G requirements and forms can be obtained at the
