Re: General Order 88-B Request for Authority to Alter the South La Cadena Drive Underpass Grade-Separated Highway-Rail Crossing, identified as CPUC Crossing No. 001B-538.90-B and DOT No. 746984B, in the City of Colton, San Bernardino County

Dear Mr. Cheung:

This refers to your letter, dated June 22, 2011 (received on June 28, 2011), requesting authorization, pursuant to Commission General Order (GO) 88-B, to modify the existing grade-separated crossing of Union Pacific Railroad Company (UPRR) Yuma Subdivision tracks and La Cadena Drive in the City of Colton (City), San Bernardino County. The crossing is identified as CPUC Crossing No. 001B-538.90-B and DOT No. 746984B.

South La Cadena Drive grade-separated underpass structure is a four lane roadway that crosses under UPRR's main line 1, main line 2, and Yard Lead Track freight tracks. The proposed alterations is required as part of the larger proposed Colton Crossing Project to grade separate the UPRR Yuma Subdivision track and connector track at mile post 538.57 and two BNSF Railway Company San Bernardino Subdivision main line tracks at UPRR mile post 538.67, in the City of Colton. In addition to UPRR freight trains, the National Passenger Railroad Corporation (Amtrak) operates passenger trains over the main lines.

## UPRR proposes the following alterations:

- Construct a new railroad grade separated structure north of the existing La Cadena Drive underpass structure, south of the Interstate 10 bridge structure. The new structure will include UPRR's main line 1, main line 2 and an access maintenance road; and
- Remove UPRR's main line 1 tracks on the existing La Cadena underpass structure and UPRR's main line 2 will be converted to Track 112;

The new railroad grade separated structure will consist of a single span 81 feet 0 inches long and 50 feet and zero inches wide with a minimum vertical clearance of 45 feet 3.75 inches above La Cadena Drive, which complies with the minimum clearance requirements specified in the Commission General Order (GO) 26-D of 15 feet 0 inches, therefore this authorization does not require temporary or permanent clearance deviations.

The Commission's Rail Crossings Engineering Section (RCES) investigated the request by UPRR, and finds it adequately addresses compliance and safety. As UPRR, SANBAG, Caltrans, Amtrak and City are in agreement as to the design and apportionments of the cost under the provisions of GO 88-B, the improvements as described in your request dated June 22, 2011 and summarized above are authorized.

Temporary traffic controls shall be provided in compliance with the California Manual on Uniform Traffic Control Devices (CA MUTCD), published by the California Department of Transportation. All parties shall comply with all applicable rules, including Commission General Orders and CA MUTCD.

As modifications of an existing grade-separated crossing, this project is statutorily exempt from the requirements of the California Environmental Quality Act of 1970, as amended. [California Public Resources Code 21080.13]

This authorization shall expire if the above conditions are not complied with or if the work is not completed within three years of the date of this letter. Upon written request to this office, the time to complete the project may be extended. Any written request for a time extension must include concurrence letters by involved parties in support of the time extension. If an extension is requested, RCES may reevaluate the crossing prior to granting an extension.

Within 30 days after completion of this project, UPRR shall notify RCES that the authorized work is completed, by submitting a completed Commission Standard Form G title *Report of Changes at Highway Grade Crossings and Separation*. UPRR should also submit an updated FRA inventory form to the Federal Railroad Administration, reflecting the changes. CPUC requests a concurrent copy of the updated inventory form be submitted to rees@cpuc.ca.gov.
