Re: Time Extension Request for XREQ 2010050003 (G.10-05-004) to Modify Workman Mill Road At-Grade Highway-Rail Crossing, Identified as CPUC No. 003-13.90 and DOT No. 811063U in the City of Industry, County of Los Angeles.

Dear Mr. Asgian:

This refers to your letter, dated on June 3, 2014, received by us on June 5, 2014, requesting a second time extension to modify the Workman Mill Road at-grade highway-rail crossing (crossing) of the Union Pacific Railroad Company (UPRR) Los Angeles Subdivision tracks in the City of Industry (City), Los Angeles County. The crossing is identified as CPUC No. 003-13.90, and DOT No. 811063U.

The original authorization was granted on June 10, 2010, and expired on June 10, 2012. A time extension was granted on June 26, 2012, for an additional of two-year period. Construction of the project was not completed due to project logistic and sequencing. Los Angeles County Sanitation Districts (LACSD) is requesting an additional two years to complete the crossing modifications. The City, Los Angeles County (County), and UPRR provided concurrence to the time extension request.


The California Public Utilities Commission's (Commission) Rail Crossings Engineering Section (RCES) investigated the request by LACSD and finds that there has been no substantial change in circumstances since granting the original authority. Since LACSD, City, County, and UPRR are in agreement and have no objection to the requested time extension, you may proceed with the modifications as previously authorized by the Commission on June 10, 2010, with a two-year time extension. This authorization shall expire on June 23, 2016.

Within 30 days after completion of this project, LACSD shall notify RCES that the authorized work is completed, by submitting a Commission Standard Form G titled *Report of Changes at Highway Grade Crossings and Separations*.
