General Order 88-B Request for Authority to Alter Rohnert Park Expressway Highway-Rail Crossing, CPUC Crossing No. 005-47.40 and DOT No. 498674W in the City of Rohnert Park, Sonoma County

Dear Mr. Gamlen:

This refers to your letter dated July 28, 2016, received by us on July 28, 2016, requesting authorization, pursuant to California Public Utilities Commission (Commission) General Order (GO) 88-B, to alter the Rohnert Park Expressway at-grade crossing of Sonoma Marin Area Rail Transit (SMART) track in the City of Rohnert Park (City), Sonoma County. The crossing is identified as CPUC Crossing No. 005-47.40 and DOT No. 498674W.

The single track crossing is equipped with two curb mounted Commission Standard 9A (flashing light signal assembly with automatic gate arm and additional flashing light signals over the roadway on a cantilevered arm), two median mounted Commission Standard 9 (flashing light signal assembly with automatic gate arm) and two Commission Standard 8 (flashing light signal assembly) warning devices. Northwestern Pacific Railroad Company (NWP) runs approximately 2 freight trains per week at a maximum speed of 45 mph over the crossing. North Coast Railroad Authority (NCRA) is the State agency charged with bringing freight operations to the Highway 101 corridor. NWP is the freight operator contracted by NCRA. SMART transit passenger service is scheduled to begin in late 2016 with a projected 32 trains per day. The average daily traffic on Rohnert Park Expressway is 23,170 vehicles.

There is a multi-use pathway (pathway) that runs along the east side of the SMART right-of-way.

The proposed alterations as indicated in the request letter and/or shown in the attachments shall consist of:

- Constructing Americans with Disabilities Act (ADA) compliant pre-cast concrete pedestrian ramps with detectable warning strips in the southeast and northeast quadrants;
- Installing a striped crosswalk on the east side of the crossing;
- Constructing a pedestrian refuge in the eastern median;
- Installing two far side traffic signal poles and mast arms with signal heads;
- Installing three near side traffic signal poles with signal heads;
- Installing four pedestrian push button poles with pedestrian push buttons;

- Installing a controller cabinet and service cabinet;
- Installing vehicle detection loops for eastbound and westbound traffic;
- Installing handrails to form a pedestrian Z-Gate at both sidewalk approaches on south side of the crossing;
- Installing ADA compliant detectable warning tactile strips on both sidewalk approaches on the south side of the crossing, located a minimum of 12 feet from the centerline of the track;
- Installing fencing along the pathway on the south side of the crossing to channelize pedestrians to the sidewalk;
- Applying California Manual on Uniform Traffic Control Devices (CA MUTCD) compliant signage and pavement markings, including R8-8 “DO NOT STOP ON TRACKS”, R10-6 “STOP HERE ON RED” and W16-7P crosswalk warning signs, as shown on plans.

Commission’s Rail Crossings and Engineering Branch (RCEB) staff has investigated SMART’s request, and finds it adequately addresses compliance and safety. As SMART and the City are in agreement as to the design and apportionments of the cost under the provisions of GO 88-B, you may proceed with the improvements as described in your request letter, attachments, and summarized above.

SMART must ensure that Emergency Notification Signs are installed to comply with CFR 234.309.

Temporary traffic controls shall be provided in compliance with Section 8A.08, Temporary Traffic Control Zones, of the CA MUTCD, 2014 Edition, published by the California Department of Transportation.

All parties shall comply with all applicable rules, including Commission General Orders and CA MUTCD. This project is categorically exempt from the requirements of the California Environment Quality Act of 1970, as amended [California Pubic Resources Code 21084].

This authorization shall expire if the above conditions are not complied with or if the work is not completed within three years of the date of this letter. Upon written request to this office, the time to complete the project may be extended. Any written request for a time extension must include concurrence letters by involved parties in support of the time extension. If an extension is requested, the RCEB may reevaluate the crossing prior to granting an extension.


Within 30 days after completion of this project, SMART shall notify RCEB that the authorized work is completed, by submitting a completed Commission Standard Form G. Form G requirements and forms can be obtained at the Commission web site Form G page at <http://www.cpuc.ca.gov/PUC/safety/Rail/Crossings/formg.htm>. This report may be submitted electronically to rceb@cpuc.ca.gov.

At the conclusion of the project, SMART should submit an updated Federal Railroad Administration (FRA) inventory form (Form F6180.71) to the FRA, reflecting the changes. 49 CFR 234 Section 234.409 requires the railroads to submit periodic crossing inventory updates a minimum of once every three years.
