Re: Time Extension Request for XREQ 2014120003, XREQ 2015010007 and XREQ 2015010008, regarding the Ballpark Village Project in City of San Diego, San Diego County.

Dear Mr. Doringo:

This refers to your letter dated December 31, 2017, and received by us on February 2, 2018, requesting a time extension to comply with the provisions of the California Public Utilities Commission (Commission) General Order (GO) 88-B authorization letters issued on January 27, 2015. The authorization letters discussed modifications at three at-grade highway-light rail transit crossings (crossings), identified in the table below, of the San Diego Metropolitan Transit System (MTS) / San Diego Trolley, Inc. (SDTI), in the City of San Diego (City), San Diego County. MTS provided concurrence to the time extension request.

The modifications are adjacent to the Ballpark Village development.

The Commission's Rail Crossings and Engineering Branch (RCEB) investigated the request by the City and finds that there has been no substantial change in circumstances since granting of the original authority. Since MTS is in agreement and has no objection to the requested time extension, you may proceed with the modifications as previously authorized by the Commission on January 27, 2015, with a one year time extension. This authorization shall expire on January 26, 2019.

In all other respects, the approval letters issued on January 27, 2015, shall remain in full force and effect.
