Re: Time Extension Request for General Order 88-B for Authorization to Modify Five Grade-Separated Highway-Rail Crossings of the California Department of Transportation Interstate 8 and Interstate 5, in the City of San Diego, San Diego County.

Dear Mr. Owsiany:

This refers to your letter, dated December 15, 2019, received by us on January 16, 2020, requesting an extension of time to comply with the provisions of the California Public Utilities Commission (Commission) General Order (GO) 88-B approval letter, on January 25, 2016, authorizing the alteration of the five California Department of Transportation (Caltrans) Interstate 8 (I-8) and Interstate 5 (I-5) grade-separated highway-rail crossings (crossings) at the North County Transit District (NCTD) Coaster track in the City of San Diego (City), San Diego County. The crossings are identified in Commission records as follows:

San Diego County Association of Governments (SANDAG) is managing the project for the crossing modification, which consists of installing an additional mainline track west of the existing railroad track and realigning the existing mainline track.

The GO 88-B authorization expired on January 25, 2019. SANDAG is requesting an extension of 36 months to complete the alterations of the of the track relocation and addition. Caltrans and NCTD have concurred with the requested time extension.

The Commission's Rail Crossing and Engineering Branch (RCEB) investigated the time extension request and find that there has been no substantial change in circumstances since the granting of the original authority. RCEB has no objections to the requested extension.

In consideration of the above, SANDAG is granted the time extension of the time to January 25, 2022, to complete the alterations of the crossing. In all other respects, the approval letter issued on January 25, 2016, shall remain in full force and effect.
