9.1 SBC CALLING SERVICES™ CARD

9.1.1 SERVICE DESCRIPTION

SBC Calling Services™ Card is a California IntraLATA service available to residential telecommunications customers. In order to access the SBC Calling Services™ Card, the customer must place their call using a unique toll free number¹.

9.1.2 RATE REGULATIONS

The SBC Calling Services™ Card will provide residential customers and customers of other SBC Local Telephone Companies who use their SBC Calling Services™ Card in California with a flat per minute rate². A service charge will also be applied to each call. The Utility's customers on an optional calling plan (OCP) with a separate California IntraLATA calling card rate will be charged at the OCP rate. These rates do not apply for calling card calls originating from the Utility's resold access lines.
