Re: Guidance on Modification of CASF Broadband Adoption Project Workplans due to COVID-19

In a <u>letter</u> dated March 30, 2020, the California Public Utilities Commission (CPUC) Communications Division (CD), in response to the COVID-19 emergency, recognized a potential impact to the CASF Adoption, Consortia and Public Housing projects and grantees. In order to mitigate this potential impact, the letter stated that the CD is considering taking various steps including extending projects, modifying workplans (when feasible, grantees may modify their curriculum and work plans from classroom-based settings to remote options such as online webinars, or self-paced, individual learning at home) and expediting payment request reviews.

In a <u>letter</u> dated May 1, 2020, the CPUC's Executive Director authorized the extension of completion dates for all projects currently in progress and suspending all project completion deadlines during the pendency of the Governor's Executive Order N-33-20. The letter stated that the CPUC will provide further instruction concerning applicable project deadlines upon the lifting of the Governor's Executive Order.

This letter serves to inform grantees that they may make curriculum and workplan modifications necessary to meet the COVID-19 emergency without further approval from the CPUC if those modifications consist only of a reallocation of funds within the approved budget and/or a change of milestone/activity timelines within the approved project timeframe. However, grantees must notify CD of such modification by e-mailing CASF Adoption@cpuc.ca.gov or CPUC Housing@cpuc.ca.gov within 30 days of the change. Any other changes require approval from the CD Director. To request approval of such proposed changes, please use the attached letter format in Attachment A and submit the request to the CD Director for consideration at least 30 days before the anticipated change.
