The Hillview Water Company, Inc. is pleased to present to you this year's Annual Quality Water Report for our water system in Raymond, California. This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect your water resources. We continually test the drinking water quality for many constituents as required by both state and federal regulations. This report shows the results of our monitoring for the period of January 1 through December 31, 2013 and may include earlier monitoring data.

We are committed to ensuring the quality of your water. The water we deliver to you comes from hard rock wells which is drawn from underground fractures. We operate five wells in the Raymond area. Wells #2 and #10 are located in our north well field. Wells #8 and #9 are in Horse Canyon. Well #11 is in the Rough Rider area.

A source water assessment was conducted for the active water supply wells by the California Department of Health Services on August 9, 2002. The assessment determined that the water source is most vulnerable to the following activities:

- Activities associated with contaminants detected in the water supply
  - x Septic Systems – low density
  - x Surface Water – streams, lakes, rivers
  
- Activities not associated with any detected contaminants
  - x Surface Water – streams, lakes, rivers
  - x Automobile – gas stations
  - x Septic Systems – low density, historic gas station

As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

The California Department of Public Health has asked us to make this report easy to read and understand. (They also, however, have required us to use certain language and phrases which, sometimes, makes things somewhat difficult to understand.) To help you better understand some terms you might not be familiar with, we've provided the following definitions:

**Maximum Contaminant Level (MCL):** The highest level of a contaminant that is allowed in drinking water. Primary MCLs are set as close to the PHGs (or MCLGs) as is economically and technologically feasible. Secondary MCLs are set to protect the odor, taste, and appearance of drinking water.

**Maximum Contaminant Level Goal (MCLG):** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs are set by the U.S. Environmental Protection Agency (USEPA).

**Public Health Goal (PHG):** The level of a contaminant in drinking water below which there is no known or expected risk to health. PHGs are set by the California Environmental Protection Agency.

**Maximum Residual Disinfectant Level (MRDL):** The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

**Maximum Residual Disinfectant Level Goal (MRDLG):** The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

**Primary Drinking Water Standards (PDWS):** MCLs and MRDLs for contaminants that affect health along with their monitoring and reporting requirements, and water treatment requirements.

**Secondary Drinking Water Standards (SDWS):** MCLs for contaminants that affect taste, odor, or appearance of the drinking water. Contaminants with SDWSs do not affect the health at the MCL levels.

**Treatment Technique (TT):** A required process intended to reduce the level of a contaminant in drinking water.

**Regulatory Action Level (AL):** The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

**Variances and Exemptions:** Department permission to exceed an MCL or not comply with a treatment technique under certain conditions.

**Non-Detects (ND):** Not detectable at the testing limit. (Laboratory analysis indicates that the constituent is not present.)

**ppm:** Parts per million (ppm) or Milligrams per liter (mg/l) – one part per million corresponds to one minute in two years or a single penny in \$10,000.

**ppb:** Parts per billion (ppb) or Micrograms per liter ( $\mu\text{g/L}$ ) – one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

**ppt:** Parts per trillion (ppt) or Nanograms per liter (ng/L) – one part per trillion corresponds to one minute in 2,000,000 years, or a single penny in \$10,000,000,000.

**ppq:** Parts per quadrillion (ppq) or Picogram per liter (pg/L) – one part per quadrillion corresponds to one minute in 2,000,000,000 years or one penny in \$10,000,000,000,000.

**pCi/L:** Picocuries per liter (pCi/L) – is a measure of the radioactivity in water.

**The sources of drinking water** (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

**Contaminants that may be present in source water include:**

➤ *Microbial contaminants*, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

- *Inorganic contaminants*, such as salts and metals, that can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- *Pesticides and herbicides*, that may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- *Organic chemical contaminants*, including synthetic and volatile organic chemicals, that are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, agricultural application, and septic systems.
- *Radioactive contaminants*, that can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the USEPA and the California Department of Public Health (Department) prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. Department regulations also establish limits for contaminants in bottled water that provide the same protection for public health.

Tables 1, 2, 3, 4, and 5 list all of the drinking water contaminants that were detected during the most recent sampling for the constituent. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. The Department allows us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of the data, though representative of the water quality, are more than one year old.

### Additional General Information on Drinking Water

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Hillview Water Company is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Hillview Water Company, Inc. is pleased to announce that we have received Proposition 50 and 84 grants from the California Department of Public Health. This money comes from the SAFE DRINKING WATER, WATER QUALITY AND SUPPLY, FLOOD CONTROL, RIVER AND COASTAL PROTECTION BOND ACT OF 2006. These grants are for correcting the supply and contaminant problems by adding water source and treatment, which will include system improvements. When the project is complete, these MCL exceedances for Uranium, Arsenic, and Nitrate will be eliminated for the entire Raymond water system.
