

## **Cobb Mountain Water Company**

### **NOTICE OF PROPOSED SALE TO COBB AREA COUNTY WATER DISTRICT**

By Advice Letter No. 47-W, Cobb Mountain Water Company (CMWC) requests approval of the revocation of The Certificate of Public Convenience and Necessity and all CMWC's tariffs due to its sale to the Cobb Area County Water District (CACWD).

CMWC requests authority under General Order 96-B, General Rules 4.2 and 7.6.2; Water Industry Rule 7.3.3(9); and Section 851 of the Public Utilities Code to complete the sale and transfer of service of CMWC to the CACWD.

The Commission staff will make a thorough investigation of the utility's request. Following the investigation, the Commission may grant the utility's request or may deny it.

Customers who would like to provide any other information or comments regarding this request should write to the Commission.

There are two ways to respond to this notice. You may send a protest to the Commission and, if you do, you must send a copy of the protest to CMWC, or you can send a response to the Commission.

#### **PROTEST AND RESPONSES:**

A protest is a document objecting to the granting in whole or in part of the authority sought in this advice letter filing. A response is a document that does not object to the authority sought, but nevertheless present information that the party tendering the response believes would be useful to the Commission in acting on the request.

A protest must be mailed within 20 days of the date of this notice. A protest must state the facts constituting the grounds for the protest, the effect that approval of the advice letter might have on the protestant and the reasons the protestant believes the advice letter or part of it is not justified. If the protest requests an evidentiary hearing, the protest must state the facts the protestant would present at an evidentiary hearing to support its request for whole or partial denial of the advice letter.
